V. CONSENT AGENDA ORDINANCES

ORDINANCE NO. 8069 AMENDING SECTION 3-1313 OF CITY CODE

Section 3-1313 of the Kearney City Code presently indicates that no license shall be issued for the sale of alcoholic liquor within 150 feet of any church, school, or hospital. A concern has been raised that if a church were to locate in the downtown district that

might limit certain properties uses for a bar or tavern and this might be even more restrictive given the lack of separation between properties in the downtown district. City staff has prepared a code change which indicates that this separation restriction will not apply to properties located in the downtown area and have added that language to Section 3-1313.

It should be noted that <u>Neb. Rev. Stat.</u> § 53-177 has a similar restriction; however, the Liquor Control Commission has the ability to issue a license to a business that locates within 150 feet of any church if the Commission gives notice to the church and holds a hearing should the church request one. As always, the Liquor Control Commission would have the final say on whether a liquor license would be issued for a particular location.

Council Member Nikkila introduced Ordinance No. 8069 amending Section 3-1313 "Alcoholic Beverages; Sale at Retail; Restrictions as to Locality" of Article 13 "Alcoholic Beverages" of Chapter 3 "Business Regulations" of the City Code to provide that the restrictions as to locality does not apply to properties located in the downtown business district, and moved that Ordinance No. 8069 be placed on first reading by title and that the City Clerk be permitted to read Ordinance No. 8069 on its first reading. Council Member Clouse seconded the motion to place Ordinance No. 8069 on first reading. President of the Council asked for discussion or if anyone in the audience was interested in the ordinance. No one responded. Clerk called the roll which resulted as follows: Aye: Clouse, Lammers, Nikkila. Nay: None. Buschkoetter and Lear absent. City Clerk read Ordinance No. 8069 by title on first reading.

ESSENTIAL AIR SERVICE LETTER OF SUPPORT

Mayor Clouse opened for discussion submitting a Letter of Support for Essential Air Service to the Department of Transportation and to consider Resolution No. 2016-58.

They have until the end of March to submit a letter to Department of Transportation. They have had one committee meeting and they have had visits from various aircraft and they have visited others out in Denver so they are still gathering information and hope to have that recommendation in the next 7-10 days.

WHEREAS, increased traffic to serve central Nebraska would be a valuable asset to the community and surrounding area.
